1. All Sole Ownerships or Partnerships must provide copies of the owner's or the entire partner's Identity Documents.
2. All Company Directors or Members of a Company/Close Corporation must provide copies of their Identity Documents.
3. Close Corporations and Companies must provide a copy of their letterhead indicating physical address and CIPC Registration document.  
Note Clause 16 of Credit application form – Continuing covering surety ship to be completed and signed by a member of the Close Corporation who warrants that he/she has the authority to do so, and witnessed.
4. All applicants to provide a copy of their V.A.T. (Value Added Tax) Registration Certificate (i.e. VAT201 form) or, if not registered for V.A.T. then a letter on a letterhead confirming this.
5. All applicants to provide, an original letter from their bank confirming their account details.
6. All applicants to provide a bank code from their bank.
7. All requested copy documents must be certified as true copies of the originals by a Commissioner of Oaths.
8. Website address and e-mail addresses of all Directors/Members/Sole Proprietors must be provided.
9. Certificate of Good Health if the only shareholder.

**Please take note of the following listed below:**

- Kindly ensure that the listed members/owners sign off the credit application.
- If the above is not the case we require a letter stating signatory authority has been granted.
- All letters addressed to EHD Components should be on a company letterhead, dated and signed.
- Please note that all orders for goods be charged to an account must be writing.
